### **Participants**

The seminars were attended by a wide range of attendees including refugees and asylum seekers and representatives of RCOs - particularly from Somali RCOs, students and academics, practitioners from refugee and other voluntary agencies, teachers, social workers and interested individuals.

#### Main issues discussed

This section includes a list of the main issues addressed by the series as well as a more detailed commentary on the discussions that took place after each presentation.

- The concept, formation and development of refugee communities and refugee community organisations (RCOs) in the UK;
- The history of refugee settlement in the UK;
- The role of refugee communities in the UK both in terms of their members and British society and identity as a whole;
- The UK policy context;
- The social identities of refugees in the diaspora;
- A typology of refugee communities/RCOs and refugee community development?
- The capacities of and constraints on refugee communities and RCOs;
- The interplay of home factors and the local settlement context on refugee settlement and community formation;
- Exile communities and transnationalism, particularly their role in post-conflict reconstruction;
- The needs and roles of specific groups within refugee communities particularly women and children both accompanied and unaccompanied;
- Inter generational politics within refugee communities;
- The fragmentation of refugee communities and the proliferation of RCOs;
- Methods for and issues involved in researching refugee settlement.

The discussions that followed each seminar were lively, varied and usually quite specific to the themes, arguments, research and/or population being discussed. Nonetheless some common themes and recurring interests did emerge in the discussion periods.

The **fragmented quality of refugee communities** was a recurring theme. The inability of a single RCO to serve the entire population and the ensuing but logistically challenging need to coordinate with many other RCOs was discussed. The constraints and feelings of entrapment that some individual members of a refugee community can experience as a result of their membership in that group were also raised. The sometimes stark divisions between generations were explored. The potential of tensions created by a refugee's simultaneous involvement in events in his/her country of origin and host country featured in several discussions.

The **limitations of refugee community organisations** were discussed at length. There was much discussion of the lack of local authority and national government support for RCOs, and of their own inability to merge with mainstream organisations or understand English bureaucracy. RCOs are primarily concerned with integration, but refugees and asylum seekers are 'at the bottom of the pile' in the local authority departments involved in education, housing, employment etc. RCOs were criticised for failing to provide better education and training programmes, though it was pointed out that their English language training facilities were improving. There was broad agreement that RCOs do not tend to focus on transformative work, as it requires a lot of support, host community involvement and must be very participative. The human resource limitations of RCOs were also noted – they often focus around a single or small group of founding individuals, and/or are staffed by volunteer asylum seekers and refugees who must eventually move on to paid employment. The limited role of RCOs in coordinating remittances was also discussed.

The **limitations of research** came up at most of the seminars. It was noted that the time lag between the occurrence of research and its publication means that the findings are often out of date and inaccurate by the time they are published. The necessity of researchers to target their proposals to the interests of funders was also discussed, and it was agreed that this impeded the usefulness of research. Competition for funds also creates tensions and fragmentation between organisations, which is unhelpful. The scarcity of accurate figures on the numbers of asylum seekers and refugees was noted as a serious impediment to the research process. Fatigue among the refugee communities being researched was also noted as a serious problem.

Finally, the place and unique features of both women and unaccompanied asylum seeking children (UASC) within refugee communities was raised at several points. It was noted that in some refugee communities, the gender roles are turned upside down by the prominence of women in the organisational structure of RCOs and that there is a simultaneous weakening of the traditional role of men as a result of the refugee experience. On the other hand, the fact that men dominate many RCOs differentiates them from other grassroots organisations, which are often dominated by women; this was noted as a distinguishing factor between RCOs and other host community grassroots organisations.

The effect of turning 18 on UASC was raised on several occasions, as was the disenfranchisement that can be felt as a result of not fully knowing either their host or their original culture. They fact that UASC are often lumped into the single category of 'UASC' despite a huge variety of other needs and characteristics was also discussed.

### ICAR community development: resources list

This list is the result of some preliminary sourcing work conducted in 2002. It includes material sourced using databases (but *not* a complete search on all available database sources), material recommended by others working in the sector and material identified by ICAR staff. Some new material has been added but the list has not been systematically updated since autumn 2002.

It is worth noting that beyond the section on UK refugee community development, the material cited illustrative – clearly there is a lot more material on community development in relation to ethnic minorities and in general than is cited here. Secondly, some of the material that may be useful to researchers in relation to refugees and community development is 'invisible' in terms of database searching, etc. due to the way in which it is catalogued. Hand searching of material on refugees in the UK would reveal a lot more – particular areas to look at would be mental health and psychosocial well-being ('community' often being cited as key to this), dispersal and early refugee resettlement programmes (Refugee Action has quite a good body of material on this and ICAR can make available a list of their publications, alternatively visit <a href="www.icar.org.uk">www.icar.org.uk</a> and search the resources database), particularly those that also involved dispersal such as the Vietnamese.

Some references are incomplete - this is due to incomplete references obtained from the sources searched. ICAR will endeavour to complete the references in due course.

If this list proves useful to you, *ICAR kindly requests that you cite our contribution to your research/other work in any published material*. If you identify any additional useful material, please let ICAR know so that the list can be updated for others. Finally, if any of the references prove particularly useful (or useless) then your feedback would be appreciated so that the list can be refined and particularly useful pieces highlighted.

### Refugee community development (UK)

Lots of publications mention community development, but do not address it specifically or elaborate on the idea. This list tends to include publications that focus on this issue or are important for this issue rather than the more generalist reports that have 'need more refugee community development' type comments in the recommendations section. However, a full literature review could look at all these reports and how community development and 'community' is treated in these publications – i.e. through discourse analysis.
